# **EDUCATION COMMITTEE**

#### **Merritt Fire Department**

The Superintendent noted the excellent response by the members of the Merritt Volunteer Fire Department and the great support the department provided the school district with the initial clean-up. He noted that he has debriefed with the Fire Chief and from a Fire Department's point of view, the overall incident was handled appropriately.

#### **Presentation: Youth Voice**

The Assistant Superintendent introduced grade 10 MSS student Tyler Thomson who provided an overview of the Youth Voice program occurring at Merritt Secondary School. Ms. Thomson provided the results of a survey presented to the students at the school.

#### **Presentation: ICS**

The Secretary Treasurer introduced Interior Community Services Director Chelsea Morrey. Ms. Morrey provided an overview of the number of services offered at ICS.

Ms. Morrey formally requested the Board consider applying for a Temporary Use Permit (TUP) for Coquihalla Middle School. She recommended that an advisory committee be created as the gate keepers in order to determine what fee based services would be allowed in the building. The CEO, Kelly Keland for ICS, noted that a pediatrician out of Kamloops, Dr. Ogilvy, has expressed an interest to come to Merritt once a month. The goal of the advisory committee would be to approve or not approve the fee based business. Ms. Morrey noted the advisory committee could be made up of members from the School District, the City of Merritt and Interior Community Services.

## Kindergarten Registration Update

The Superintendent noted that registration for Kindergarten is at 71 students after the two week registration period. He noted the average March registration is 76 with a low of 54 and a high of 96. He reported that typical registrations over the last nine years have been 115 to 145 with a mode of 140. The Superintendent noted that Interior Health birth information has a prediction at 160.

## **CMS Pathway**

The Board Chair noted that a concern was brought forward from a community member regarding the pathway at CMS by Armstrong Street.

He noted the City of Merritt provided an easement and then approximately five years ago, paved the easement. This has acted as a funnel to the school district property which created a path to form.

The Vice Chairman provided some history regarding the easement and noted that it was put in to gain access to the school property. He noted that up to one hundred people use this access point on a daily basis.

The Board Chair further noted that he has met with the Mayor and the funnel to school district property was acknowledged.
