# 2017/2018 Funding Update

The Secretary Treasurer provided an overview of the estimated operating grant funding in May 2017 compared to the interim operating grant funding in December 2017. He noted that the overall dollar figures are down slightly from the estimated in March. The main reason for the change is due to the audited file review actuals.

## **Investment**

The Secretary Treasurer noted that the District investment of one million dollars has recently matured. He noted the normal process has been to obtain quotes and provide a recommendation at a board meeting. He advised that today the Bank of Canada rates have increased a quarter percentage point and would like to wait and see what happens to the investment opportunities. He recommended that the District reinvest the one million dollars and requested that approval be granted to the Audit and Finance Committee to oversee this approval and a reporting out would take place at the next board meeting.
