## Local Education Agreement Negotiations and Funding

#### 2020/2021 Five-Year Capital Plan

#### 2019/2020 Operating Grants

The Secretary Treasurer provided a memo and discussed the Ministry's estimated operating grants for the next fiscal year based on the district enrolment projections submitted in February 2019. Operating Grant Comparisons show an increase of \$198,771 from the current year's funding.
