#### **EDUCATION COMMITTEE**

The Assistant Superintendent introduced returned Student Trustee Nicholas Willey and new Student Trustee Kassie Moyes.

# Presentation - South Central Interior Distance Education School

Assistant Superintendent Aziz introduced Principal Goetz of South Central Interior Distance Education School (SCIDES), who presented alongside Teacher Mr. French on the adult education. There are 151 courses, free upgrading to obtain a dogwood diploma, and career zones offered for adults throughout the Province at SCIDES. The school is seeing much growth but still needs more exposure.

## **Recognition for Teacher Robert French**

Superintendent McNiven discussed the importance of recognizing Teacher Robert French for his work in the District. Mr. French was the runner up for the Premier's Award for Excellence in Education – New Teacher. Board Chair Comeau presented Mr. French with a local piece of art in congratulations and recognition for his outstanding work.

## Field Trips

There are no new field trips to report.

#### Class Size Average

The Superintendent distributed a memo and a report on class size configuration. He provided an overview of elementary class configuration, 2018/2019 class size averages and historic class size averages for both Nicola-Similkameen and for the Province. The District is under the allowable class size in all categories with very little split classes.

# **Ministry of Education Partner Liaison Meeting**

The Superintendent provided a memo and presented a summary the Ministry of Education's Partner Liaison meeting that took place on October 17-18, 2019. Topics included the Framework for Enhancing Student Learning and Strategic Planning. Enhancing Student Learning is understanding the common ground, outcomes and the capacity to build. Strategic Planning involves alignment, long term planning and support. The BC Principals' and Vice-Principals' Association's Strategic Plan was discussed. It was also noted that a MyEd data collection pilot project on the Provincial level will be taking place while maintaining the Freedom of Information Act. Overall the meeting was productive and informative.

#### **Strategic Planning**

The Superintendent distributed a memo and spoke about the third strategic planning session that took place on October 28, 2019. The recommendations to move forward are to modernize and Indigenize the current vision, measure and report out on the progress of the plan, to consider stakeholder groups and questions and to focus on the goals. The current plan has a strong foundation but is lacking effective communication. Progress has been made in the efforts of creating a stakeholder group to focus on children in care and a third party "Imagine a Circle" will collect the information.

#### **Surveillance Cameras**

The Operations Manager circulated a memo and provided the Board with a followup and a quote from Aspen Electric on the Alhua surveillance system for the following schools:

Collettville Elementary Merritt Central Elementary Merritt Secondary John Allison Elementary Princeton Secondary Nicola-Canford Elementary

The District has spent approximately \$18,000 on vandalism repairs in a one-year period. Cameras are expected to deter vandals. More discussion is needed before proceeding with the purchase and installation of surveillance at all six suggested schools. The Board would like more options and quotes to be provided at the December 11, 2019 board meeting. Due to the cost and meaning of the calming space located at Nicola-Canford Elementary School, it was agreed that surveillance can go ahead for that location only.
