EDUCATION COMMITTEE

Vaping Response Procedures

Assistant Superintendent Aziz distributed a memo and requested the Board's feedback regarding the appropriate age to begin educating students about vaping/smoking, what resources to provide students and parents, and what off property vaping rules should look like.

The Board would like to thank Assistant Superintendent Aziz along with Audrey Ackah at the BCSTA, for their dedicated work on this project, which will provide clear direction and continuity throughout the district and the province.

BC Adolescent Health Survey Report and EDI Report

The Superintendent provided two documents titled "Balance and Connection in Thompson Cariboo Shuswap: The Health and Well-Being of Our Youth" and "EDI BC: 2019 Provincial Report". The Superintendent provided an overview of each report.

Kindergarten teachers tested over 43,000 children and reported out on these early learners helping to compile the data for the EDI BC" 2019 Provincial Report. The data consists of students' developmental skills, mental and physical health, and much more.

The Balance and Connection in Thompson Cariboo Shuswap: The Health and Well-Being of Our Youth was a more detailed report on difficult but important topics concerning the youth in our district. Topics such as safety in the schools and community, mental and physical health, substance use, sleep deprivation, suicide rates and self harming.

Strategic Planning Update

The Superintendent circulated a memo providing a timeline of events related to the strategic planning process. He also spoke to further progress for the consultation work taking place in January and February 2020.

December Facility Upgrade and Maintenance

A memo was distributed by the Operations Manager and the Secretary Treasurer provided the Board with an update of maintenance operations for the month of December. Recently completed projects include replacing an aging boiler at Merritt Secondary, upgrades to fencing, baseball backstop, basketball backboards, public address (PA) system upgrade, and various painting. The final bus is to arrive soon which has wheelchair access and will be placed according to its need throughout the district.

Ministry of Education Funding Announcement

The District will receive a total of \$23,813,893 in operating grant funding. Adjustments will be made to the Amended Annual Budget to incorporate this funding. The Ministry additionally updated their Summary of Grants to Date which will be accounted for in our Amended Annual Budget.

2020/2021 Budget Process

Per Diems and Mileage Rates

The Secretary Treasurer circulated a memo and referred to Policy No. 205.1 while advising Trustees of the mileage rate increase from \$0.58/km to \$0.59/km which is effective January 1, 2020. In addition, per diem rates have been increased to:

This increase is to pair with the BC School Trustees' Association (BCSTA) per diems rates. If the BCSTA rates increase again after the 2020 Provincial Council meeting, the District will match those rates accordingly.
